### 2. Notes of Previous Meeting & Matters Arising (Not covered below)

2.1. Minutes from the last meeting have been posted on SharePoint. No comments or alterations had been received and DAA proposed these were a true record of the of the previous meeting.

### 3. Topics for Discussion

### 3.1. CP/TC and ToR Review

3.1.1.Proposal for new arrangements and associated ToR.

All the papers can be found on Sharepoint. The committee was content with the proposed simplified TC ToR.

DAA advised he, the Master, Clerk, and Regional Chairs would have a conference call at 23.30 on the 5<sup>th</sup> February that might include a review of the Co-ordination Panel working. Therefore, discussion of CP ToR should be postponed until after the Regional Call when there is a better understanding of the appetite for joint working.

3.2. Aptitude Testing

At the previous Court meeting, Past Master Clive Elton suggested that all wannabe pilots should undergo aptitude testing and the Court requested DAA to write to the CAA stressing its importance and seeking its introduction as a formal requirement. The TC agreed; hopefully aptitude testing will filter out those without the aptitude to make an effective professional pilot before they spend large sums for training. TC suggested removing mention of the Hon Company providing the Aptitude Testing for £155 and aptitude selection success rates should be added.

RT will to try to obtain data from the MoD that correlates aptitude scores and future success in training.

GC will approach Bristow to see if they hold any similar data.

Once all information is received, DAA will write to the CAA.

#### 3.3. Airspace

The Chair has yet to receive any volunteers to join the Airspace Working Group. The aim of the WG needs to be identified:

- Will it take over the all airspace consultations?
- Will it look just at local cases that people in the WG need to considered?
- Will it look more strategically at airspace change policies?

Many of the Airspace issues impact the GA community more that other areas of aviation. DAA has several consultations open, reflected in SharePoint folders. DC commented on the conference he recently attended (report also in SharePoint). DAA will forward to TC (UK ,members) any UK Airspace Change Proposals he receives for comment and asked for a 'no comment' response to confirm TC members had nothing to add.

### 3.4. Drones Interest Group

Freeman Ian Davies had asked 'Is there any plans to create an AP Focus group for Drone operators'? Papers relating to this are available on Sharepoint (3.4 & 3.4a). Next steps are to invite Ian to the next TC meeting and get his thoughts/Ideas on how the discussion group should move forward. DAA confirmed the Company has had a class of membership for Drone Users for about 12 months, the 'Unmanned Freeman/Upper Freeman'.

3.5.1.Skills Fade Refresher

AF reported he has had some progress. He has reached out to Mark Mannery Smith who represents BA's Flight Safety Group & Committee and has a meeting arranged in two weeks time. The plan is to devise a sensible trial to investigate whether a short instrument flight exercise over a couple of minutes pre-flight will refresh instrument flying (scanning) skills generally to make a difference that is measurable (in the simulator).
